ORDER:

In order to mitigate the sufferings of teaching and non-teaching staff of recognized Private Schools due to Covid-19, the Government have decided to provide assistance of Rs.2000/- and 25 kgs of rice (Sanna Biyyam) per month from April,2021 until schools reopen. Accordingly, in the reference 1st read above, the School Education department have issued necessary guidelines to the District Collectors and their Departmental functionaries for collection of data and to provide to the Finance and Civil Supplies departments for providing financial assistance and distribution of rice respectively within the schedule period i.e., from 21st to 25th of the month. Further, in the reference 2nd read above the Consumer Affairs, Food & Civil Supplies Department, have issued necessary guidelines to the Commissioner of Civil Supplies and Vice Chairman & Managing Director, Telangana State Civil Supplies Corporation Limited, District Collectors and the others concerned to take necessary action for distribution of Sanna Biyyam to teaching and non-teaching staff of recognized Private schools through the F.P. Shops, as per the requirement given by the School Education Department.

2. In this regard, now, the Finance (EBS.II) department, in the reference 3rd read above have issued Budget Release Order for an amount of Rs.15,15,00,000/ (Rupees Fifteen Crore Fifteen Lakh only) under Scheme "Subsidy on Rice (Human Resource Development)" from the BE provision 2021-22 towards assistance to recognized Private School teachers and other staff for April' 2021, in relaxation of quarterly regulation orders.

3. Government, after examination of the matter, hereby accord administrative sanction to the Commissioner of Civil Supplies Hyderabad, to utilize an amount of Rs. 15,15,00,000/ (Fifteen Crore Fifteen Lakh only) under Scheme towards meeting the expenditure for distribution of 25 kgs of rice (Sanna Biyyam) to the recognized Private School teachers and other staff for the month of April 2021, duly following the guidelines issued by the Government vide references 1st and 2nd read above.

The expenditure sanctioned at para-3 above shall be met from the Budget Release Order issued vide reference 3rd read above, duly following the procedure mentioned therein and shall be debited to the Head of account "2236-02-800-25-04-330-000 - Subsidy on Rice (Human Resource Development)", in relaxation of quarterly regulation orders.

5. The Commissioner of Civil Supplies, Hyderabad shall take necessary action, accordingly.
