ORDERS

Imphal, the 4th May, 2021

- 1. Whereas, the undersigned as Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 had issued orders dated 21/04/2021 restricting activities and notifying the whole of Greater Imphal as containment zone vide orders dated 29/04/2021.
- 2. Whereas, it has been observed with concern that people both sellers and buyers are crowding in market areas increasing the spread of Covid-19 infection and this needs to be prevented without resorting to a complete shutdown.
- 3. Therefore, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 the undersigned in his capacity as Chairperson, State Executive Committee of the State Disaster Management Authority, hereby orders additional restrictions in respect of shops and movement of people and vehicles as below in partial modification of the orders dated 29/04/2021 in areas under IMC and Greater Imphal.

A. Opening of and movement of people and vehicles

- i. Only one out of three shops/vendors (permitted category vide order dated 29/04/2021) of total shops/vendors in one location shall be allowed to open on rotational basis. If the shops or vendors are located in congested rows, then only alternate rows shall be allowed to open. Queue system should be adopted by all shops and vendors.
- ii. There shall be complete ban on movement of all vehicles (including during 6 am to 10 am), except goods vehicles, oxygen supply related vehicles, LPG and Oil tankers and vehicles of other essential services like Power supply, water supply, waste/garbage clearance, Public Distribution System, medical/covid services and vehicles of personnel of departments/organizations permitted to be functional including Public Distribution System.
- iii. Deputy Commissioners and district Superintendents of Police will prepare the roster of shops vendors in respect of (i) above. Any market/shop/vendor not complying with social distancing and causing crowding may be promptly closed by the Deputy Commissioner/Superintendent of Police.
- iv. Local markets at Khurai Lamlong, Andro Parking, Lambulane, Kongba, Pishum thong, Kwakeithel, Nagamapal, Singjamei Bazaar, Wahengbam Leikai shall remain closed.
- v. Deputy Commissioners and district Superintendents of Police may take the help of local clubs in organizing the roster and physical distancing of vendors.

- B. **Bank branches** shall remain open from 10:00 AM to 2:30 PM only for Government Transactions and transactions related to COVID-19 management and Government Projects/ urgent matters.
- i. Banks are to undertake only urgent/ time bound transactions in their branches.
- ii. Finance Department and Treasuries shall remain functional with minimal staff to discharge urgent transactions.
- Post offices shall remain open from 10:00 AM to 2:30 PM to dispose time bound works including delivery of medicines and medical equipments and shall not entertain routine business.
- C. Imphal airport shall remain open and movement of staff and passengers will continue to be permitted.
- Opening of Petrol pumps and LPG outlets and movement of staff of IOCL will continue to be permitted.
- 4. All other instructions contained in the orders dated 21/04/2021 and 29/04/2021 remain unchanged.
