### Government Notifications/ Announcements

#### GOA

##### **Strict Enforcement and Preventive Protocols**

The State Executive Committee (SEC) met on 2 April 2021 and directed the Health Department, Police and Department of Information and Publicity to carry out aggressive awareness campaigns, stressed the need for Collectors and Police to strictly implement the existing preventive guidelines to enforce covid appropriate behaviour including levying of fines for violations.

The SEC urged implementing the norm of track-test-treat and to ramp up testing facilities to ensure higher testing rate and timely declaration of RT-PCR test results to timely identify and contain the number of potential positive cases. The SEC also directed the Collectors to issue advisory to all possible crowded places, hotels, restaurants, gyms, marriage halls, industries, mall operators, etc to enforce the covid-appropriate behaviour and guidelines issued from time to time and to undertake random checks to ensure strict adherence of the SOPs.

The SEC decided that other Covid hospitals and Covid Care Centres (CCCs) should be kept ready for receiving more patients in case the need arises as the Health Secretary informed that both the District Hospitals have more than half of their bed capacity occupied. Collectors were directed to identify hotels willing for paid CCCs for those who seek such facility for institutional isolation.

SEC also emphasized carrying out aggressive vaccination drive more so by encouraging public servants and others (as FLWs) who are involved in Covid management and those who are 45 years and above apart from FLWs, HCWs, etc to opt for vaccination to build confidence amongst the general public.

### **Order on Public Gatherings**

The Government of Goa vide Order No. 8/8/2021-MAG/L&O/(Vol.I) dated 26/03/2021 under Section 144 of the Code of Criminal Procedure of 1973 issued an order due to the fresh surge in COVID-19 cases being witnessed in the state and some parts of the country and so that the situation might further aggravate due to social / religious / sports / entertainment / educational / cultural or any other form of gatherings and in order to contain the spread of the said pandemic, certain measures essential to enforce social distancing of people to prevent the spread of the disease and limit all gatherings;

- For halls of maximum capacity or a maximum of 50 persons, whichever is lower
- For hall with capacity of more than 100, gathering will be permissible up to 50% of its capacity or maximum of 100 persons, whichever is lower
- For open premises and grounds gathering up to 50% of its capacity or maximum gathering of people up to 200 persons whichever is lower

Any person contravening this order shall be punishable under Section 188 of the Indian Penal Code.

### **Circular for Functioning of all the District & Subordinate Courts**

The Hon'ble Chief Justice and other Hon'ble Judges of the Hon'ble Administrative Committee, vide Circular dated 05/04/2021, after taking into account the exponential surge in COVID-19 cases and the views of stakeholders have come up with the following guidelines for functioning of all the District & Subordinate Courts.

- All the courts shall start functioning in TWO shifts and to take up remand and urgent matters physically w.e.f. 07/04/2021
- In each shift the Judicial working hours will be of 2 hours (i.e. from 11.00 am to 1.00 p.m. and from 2.30 pm to 4.30 pm)
- In each shift, the Office working hours will be of two and half hours (i.e. from 10.30 am to 1.00 pm and from 2.30 pm to 4.30 pm) with presence of 50% of the staff every day.
- The Courts may take up other matters e.g. fixed for recording of evidence, hearing of arguments etc., via virtual platform.
- The courts may take up the matters physically which are either brought or scheduled for compromise / compounding.

- All Courts shall remain closed on every Saturday and to take up only remand and urgent matters, as being taken up on holidays.
- Only take away orders and parcels services are allowed in the Canteens located within the court premises.
- All the safety/ precautionary measures envisaged vide SOP dated 27/11/2020 shall apply mutatis mutandis

### **COVID-19 Vaccination Advisory**

The Government of Goa issued the following advisory for its employees, whether employed in the State Government Departments, Semi-Governments Organisations, Autonomous bodies or in any other aided Institutions under Government of Goa -

- All the employees above 45 years of age irrespective of having any comorbidities or not, working in any of the above entities are advised to vaccinate themselves at the earliest by visiting the nearby vaccination centres.
- All the employees shall continue to wear mask, maintain social distance and follow safety protocols on COVID-19.

## **GUJARAT**

### **Night curfew imposed in 20 cities across Gujarat**

Amid rise of Covid cases, the Gujarat Government announced a curfew from 8 pm to 6 am in 20 cities till April 30. These cities include Bhavnagar, Jamnagar, Junagadh, Gandhinagar, Anand, Nadiad, Mehsana, Morbi, Patan, Godhra, Dahod, Bhuj, Gandhidham, Bharuch, Surendranagar and Amreli, besides the four cities of Ahmedabad, Vadodara, Surat and Rajkot. The upper limit for guests at marriage parties has been brought down to 100, from the existing 200. All political and social gatherings of more than 50 persons stand suspended till April 30.

### **Increasing availability of Hospital Beds/ Equipments**

An order dated 08/04/2021 was issued by Ahmedabad Municipal Commission (AMC) and Municipal Commissioner, to augment COVID beds availability, more 1219 beds were added in 18 private hospitals in Ahmedabad to enable citizens to receive treatment at charges/ceiling fixed earlier. This would further ease the situation and more will be added as per requirement. Another notification dated 09/04/2021 was issued by AMC mentioning about 15 Nursing Homes/Hospitals with inventory of 235 beds in Ward & HDU category designated as "Dedicated Covid Health Center" in Ahmedabad. This would ease availability of beds in the city.

Gujarat government decided to convert Gujarat University Convention-cum-Exhibition Centre at GMDC Ground in Ahmedabad into fully equipped 900-bed dedicated COVID Care /hospital with 150 ICU beds with ventilators in collaboration with DRDO in two weeks. (Dated – 13/04/2021)

As declared in notification dated 5th April 2021, No. GP/15/FDC/102021/SFS-07/Z- Government of Gujarat has decided to regularize the circulation and supply of oxygen from production units located within state of Gujarat wherein it is directed to ensure uninterrupted production of Oxygen; 60% of production to be used only for medical oxygen and to be supplied to hospitals; only 40% of oxygen to be diverted to industrial use; wherein if the proportion of medical oxygen goes beyond 60%, priority shall be given to supply to hospitals vis a vis industries in case need arises.

**MADHYA PRADESH**

Madhya Pradesh Government created a special taskforce convened by Additional Chief Secretary, Health Department, Govt. of MP to support and advise state government in policy matters towards containing the spread of COVID-19 in state. The taskforce comprises representation of renowned personalities from various sectors of society with Chairman, CII MP as the only representative from industrial fraternity.

In view of rising COVID-19 cases in Bhopal city, the 'District Crisis Management groups' of the city decided to impose a 'Corona Curfew' in Bhopal till Monday, 19th Apr, 06:00 AM. Other major cities of the state i.e. Indore, Ujjain, Betul, Ratlam, Khargone, Katni, Shajapur, Chhindwara have already been observing the curfew since last week till Monday, 19th Apr. Following services are permitted to operate during the curfew:

- Industrial workers/employees & vehicles transporting raw Material & Finished Goods permitted to travel.
- Chemist, Ration shops, Hospitals, Petrol Pumps, Banks & ATM, Ambulance & Fire Brigade permitted to operate
- Citizens travelling for vaccination and to & from Bus Station/ Railway Station & Airport permitted
- Student & Exams Co-ordinators permitted to travel.

## MAHARASHTRA

### **Government of Maharashtra Revised "Break the Chain" Guidelines**

Government of Maharashtra revised guidelines "Break the Chain" on 13 April 2021 with the objective to prevent and contain the spread of the virus. As per the guidelines all industries in the essential category are exempted from restrictions and their movement and operations are unrestricted. The guidelines also mentions that essential for essential is essential. E-commerce companies are allowed to operate only for the supply of essential goods and services.

Continuous process units are allowed to operate with 50% workforce by either keeping their work force at one location and making necessary travel arrangement or by providing stay facility inside the campus (Isolation bubble). Furthermore, 10% of the managerial staff at the industries are allowed to commute to office by following COVID protocols.

All the restaurants, bars, hotels, shops, malls, shopping centers, spa, salons and beauty parlors will remain closed. Also, no religious, social, cultural and political functions of any kind to be allowed.

### GUJARAT

To prevent spread of misinformation regarding vaccines, a panel discussion on Vaccine 360 was organised with Dr S G Jain, Chief District Health Officer (CDHO) and Mr Udaykumar Tilsavat, ADHO on 5 March 2021.

### MADHYA PRADESH

The government of MP formed a special taskforce chaired by Mr Mohammed Suleman IAS, Additional Chief Secretary, Govt. of MP comprising Chairman, CII MP, Nobel laureate Mr Kailash Satyarthi, Director AIIMS (Bhopal) and other renowned Doctors and Journalists from state, to discuss and seek suggestions on required measures for containing the spread of COVID-19 in state. The first meeting of the taskforce was organized on 15 April 2021 chaired by Hon'ble Chief Minister, wherein CII made the following suggestions:

- Increasing the COVID Hospitals & testing in industrial areas & smaller towns of state
- Reducing the age limit of vaccination to 18 years and undertaking vaccination 24 X 7
- Strict adherence to safety protocols and Covid appropriate behaviour especially on wearing masks
- Commitment of industry support for providing oxygen & cylinders to administration

### MAHARASHTRA

#### Tele-ICU in Solapur, Jalna, Aurangabad

From the start of the pandemic, there has been an exponential rise in the number of cases which resulted in a shortage of COVID ICU beds in Maharashtra, shortage of Intensivists coupled with an increased Length of Stay (LOS) directly causing a further shortage of ICU beds. To combat COVID-19 pandemic, CII Foundation with the support of industry, partnered with technical agency, Springer to set-up Tele-ICU support in Govt. Medical College Solapur, District Hospital Jalna & District Hospital Aurangabad in Maharashtra.

The initiative has shown great outcomes in terms of increase in recovery rates and decrease in death rate due to COVID-19. Under this initiative, patients at high risk can be monitored remotely and are taken care by intensivists and highly trained nurses by means of a Two-way Audio-Visual camera, in real-time, just by sitting in the Command Centre miles away. Tele-ICU setup was done in a total of 98 Tele-ICU beds.

Tele-ICU has resulted in efficient delivery of care, Reduction in Length of stay, Reduction in Mortality rates, Lower costs, Reduced ICU complication rates, Increased Revenue, Low risk of spread of virus to health care staff.
