Policy Advocacy for Industry and Members' Engagement

Over the past week, the CII Secretariat in the Eastern and North Eastern Region has engaged in over 100 policy recommendations and are resolving issues that are affecting member companies and the society as a whole.

Some of the key issues that have been resolved have been in the areas of:

1. Logistics and movement of trucks and access to warehouses
2. Availability of emergency medical equipment and special apparatus for protection against COVID 19
3. Availability of healthcare services during the lockdown period through e-connect
4. Ensuring cooked food and food packets to the underprivileged and those rendered homeless during this period

5 Members' Meets where **over 400 members** interacted were organized over the past week across the Eastern Region – where CII's **"Call to Action" to support relief and rehabilitation** was announced and clarified to our members for greater interaction between industry, the civil society and the government bodies in each state and district.

Relief and Rehabilitation Activities in the States

Jharkhand

150 ration Kits distributed among 600 beneficiaries (600 kg rice, 75 kg dal, 150 kg flour, 300 kg potato, 60 kg salt) in Jamshedpur

Chhattisgarh

100 food packets distributed to migrant workers in Raipur and cooked food served to 4000 underprivileged children in Bhilai

400 ration Kits distributed (2100 kg rice, 150 kg pulse, 300 kg salt, 300 pc soap, 300 packet biscuit, 300 kg potato, 300 kg onion, 150 lt oil, 30 kg each (mirch, haldi, dhaniya) in Raipur

Odisha

40000 masks have been given to Mission Shakti under Women and Child Development Department, Government of Odisha by JSPL in Angul.
