WHEREAS vide order No.40-3/2020-DM-I(A), dated 24/03/2020, the Union Home Secretary, Ministry of Home Affairs, Government of India had issued an order under Section 10(2)(1) of Disaster Management Act, stipulating lockdown measures for containment of COVID-19 in -the country.

WHEREAS the said order was extended from time to time and was accordingly made applicable to Union Territory of Chandigarh.

Now the Chairman, National Executive Committee (NEC) vide order dated 23.03.2021 has conveyed that the guidelines for surveillance, containment and caution issued by the Ministry of Home Affairs' will be in force upto 30.04.2021

WHEREAS the issue of outbreak of COVID-19 in Chandigarh was further studied and examined by a Committee constituted by the W/AA and a considered view emerged that the following affected zones need to be declared as CONTAINMENT ZONES:-
