ORDER

Whereas, it is observed that the number of COVID-19 cases in the State particularly in East Khasi Hills district continues to rise sharply and hospital bed occupancy is nearing saturation;

Therefore, in **partial modification** to Order No. POL.75/2020/Ptl/98, dated 15-05-2021 the following Containment Measures shall be enforced in **East Khasi Hills District** w.e.f. 19th May, 2021 until further orders.

- 1. Total Lockdown shall be enforced from 8:00 PM of 19th May, 2021 till 5:00 AM of 31st May, 2021.
- 2. Inter-district movement of persons from and to East Khasi Hills District shall be restricted.
- All Central Government offices other than those notified by Home (Political) Department vide Notification No. POL.117/2020/Pt.VII/225, dated 18-05-2021 shall remain closed. Earlier exemptions stand cancelled.
- All State Government offices other than those notified by Personnel & A.R (A) Department vide Notification No. PER.62/2020/54, dated 18-05-2021 shall remain closed. Earlier exemptions stand cancelled.
- 5. State Bank of India, Main Branch and Laitumkhrah Branch shall function with limited staff for the purpose of government transactions only. All other Banks shall remain closed.
- 6. All Post Offices shall remain closed.
- 7. The Deputy Commissioner, East Khasi Hills District shall make suitable arrangements for availability of essential commodities in the localities on need basis.
- 8. Home Delivery Services limited to food / food products, dry ration, meat, vegetables and toiletries is permitted subject to prior permission and regulation by the Deputy Commissioner, East Khasi Hills District.
- 9. Funeral gathering to be restricted to 10 persons with prior permission of the Deputy Commissioner, East Khasi Hills.

Exemptions:

- 1. Health services including emergency services and vaccination.
- 2. Medicines and Pharmaceuticals.
- 3. Movement of Essential goods.
- 4. Persons travelling on Essential Government Duty viz.,
 - a. Medical Teams and officials on COVID-19 Duty
 - b. Police, Security and Armed Forces
 - c. Civil Defence and Home Guards
 - d. Fire and Emergency Services
 - e. Electricity
 - f. Water Supply
 - g. Municipal Services
 - h. Public Distribution System
 - i. Information and Public Relations
 - i. Telecommunication Services
- 5. Print & Electronic Media.

State-wide Containment Measures as issued vide Order No. POL.75/2020/Ptl/98, dated 15-05-2021 shall continue to be enforced in the State. Deputy Commissioners of other Districts are authorised to impose restrictions in their district depending on local situation.
