C I R C U L A R

In pursuance to the "Complete Lockdown" in the State of Goa w.e.f. 9.00 p.m. on 29/04/2021 (Thursday) to 6.00 a.m. on 03/05/2021 (Monday), issued by the Office of the District Magistrate, North Goa, Government of Goa, Panaji, vide Order No.8/8/2021/MAG/L&O/Vol-II/1071 dated 28/04/2021, due to a surge in COVID-19 cases, the functioning of the Courts falling in the District of North Goa shall be restricted on Friday, i.e. 30/04/2021 with minimum staff, i.e. one Superintendent/Head Clerk and one LDC for registration purpose and one Peon, from 10.30 a.m. to 1.00 p.m.

Only remand work and extremely urgent matters including Anticipatory Bail Applications, Bail Applications, Injunctions, Stay etc. shall be entertained by the Remand Judges at the respective stations at **Taluka level**.

The following arrangement is made for the Judicial Officers at each station in the North Goa District on 30/04/2021 from 10.30 a.m. to 1.00 p.m.:

Ms. Sherin G. Paul, District Judge-1 & Addl. Sessions Judge, Panaji shall deal with the remand work and extremely urgent matters including Anticipatory Bail Applications, Bail Applications, Injunctions, Stay etc. in respect of the matters

falling within the Jurisdiction of the District Courts at Panaji and of the District Judge-2 & Addl. Sessions Judge, Panaji, holding sittings at Ponda, between 10.30 a.m. to 1.00 p.m.

Ms. Kshama M. Joshi, District Judge-1 & Addl. Sessions Judge, Mapusa shall deal with the remand work and extremely urgent matters including Anticipatory Bail Applications, Bail Applications, Injunctions, Stay etc. in respect of the matters falling within the Jurisdiction of the District Courts at Mapusa, between 10.30 a.m. to 1.00 p.m.

At the Civil & Criminal Courts at Panaji, **Ms. Pooja S. Desai, Civil Judge, Junior Division & J.M.F.C., "E" Court, Panaji** shall attend remand work and extremely urgent matters including Bail Applications, Injunctions, Stay etc., between 10.30 a.m. to 1.00 p.m., on Friday i.e. 30/04/2021.

At the Civil & Criminal Courts at Mapusa, **Ms. Anusha D. Kaisukar, Civil Judge, Junior Division & J.M.F.C., "G" Court, Mapusa** shall attend remand work and extremely urgent matters including Bail Applications, Injunctions, Stay etc., between 10.30 a.m. to 1.00 p.m., on Friday i.e. 30/04/2021. The above Judicial Officer shall also hold charge of the **Civil & Criminal Court at Pernem** on the above mentioned date.

At the Civil & Criminal Courts at Ponda, **Shri Anil Scaria, Senior Civil Judge & J.M.F.C., "A" Court, Ponda** shall attend remand work and extremely urgent matters including Bail Applications, Injunctions, Stay etc., between 10.30 a.m. to 1.00 p.m., on Friday i.e. 30/04/2021.

At the Civil & Criminal Courts at Bicholim, **Ms. Suman Gad, Civil Judge, Junior Division & J.M.F.C., "C" Court,**


Bicholim shall attend remand work and extremely urgent matters including Bail Applications, Injunctions, Stay etc., between 10.30 a.m. to 1.00 p.m., on Friday i.e. 30/04/2021. The above Judicial Officer shall also hold charge of the **Civil & Criminal Court at Sattari at Valpoi** on the above mentioned date.

However, regular remand work shall be attended by the regular remand Judges on Saturday and Sunday i.e. 01/05/2021 and 02/05/2021.

The Office of the District Legal Services Authority, North Goa, Panaji shall work with one Clerk and one Peon to take up the urgent matters.

The concerned staff shall attend the Office as and when directed by the Principal District Judge and by the Judicial Officers as nominated above and also shall be available on phone calls, as and when they are communicated by the above Judicial Officers.
