Subject: Clarification regarding validity of e-passes.

Madam/Sir.

I am directed to refer Delhi Disaster Management Authority (DDMA) Order No. 364 dated 06.04.2021 regarding imposition of Night Curfew on movement of individuals in NCT of Delhi from 10:00 pm to 05:00 am till 30.04.2021. Further, DDMA has issued Order No. 373 dated 15.04.2021 with regard to imposition of Weekend Curfew on movement of individuals in NCT of Delhi from 10:00 pm on 16.04.2021 (Friday) to 05:00 am on 19.04.2021 (Monday). Vide these orders, various categories of persons related to supply of essential commodities and services have been allowed for movement during night and weekend curfew with the possession of e- pass.

In this context, it is clarified that e-pass possessed by a person for movement connected to essential goods and services during night curfew shall also be valid for weekend curfew period.
