



ORDER

RI BHOI DISTRICT.

(No. DCRB(CN)/COVID-19/1/2020/Pt.I/118,

Dated, Nongpoh the 28th April, 2021

In pursuance to Order No. POL.75/2020/PtI/86, dated 13^{th} April, 2021, NO POL.75/2020/Pt1/88, dt. 19^{th} April, 2021 & No. POL. 75/2020/Pt.I/89, dt. 21^{st} April, 2021 and inview of the rapidly rising of COVID -19 Cases in the District,

WHEREAS, it has become necessary to restrict on permited activities in the interest of health of general public to prevent against any possible spread of COVID-19 virus in the said area and the District as well.

NOW THEREFORE, I Smti. R. M. Kurbah, IAS, District Magistrate, Ri Bhoi District, Nongpoh, in exercise of the powers conferred upon me under section 144 Cr.P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 and Amendments, I, do hereby restrict the following activities w.e.f 29th April, 2021 until further Order.

- 1. In case of funerals, congregation of not more than 20 (twenty) persons will be permitted.
- 2. Wedding restricted to **50 (fifty)** persons with prior permission.
- 3. Schools located along Border areas with Assam will remain closed w.e.f 30th April, 2021 to 14th May, 2021.
- 4. Entry to the State is restricted **through Byrnihat only** and other border road i.e. **Rani Jirang, Iew Mawroh (Shakurbaria), Khulia, Marmain** to be closed with immediate effect.
- 5. All market Committees are directed to ensure that all stall owners to be vaccinated. It is requested that all persons above 45 (Forty-five) years to get themselves vaccinated prior to 30th April, 2021 so as to ensure that they are protected of the virus.
- 6. All returnees shall inform their respective COVID Community Management Committee headed by the Rangbah Shnong prior to their return. The Covid Community Management Committee will ensure availability of Quarantine Faculties for the returnee.
- 7. Locals going to Guwahati (Assam) and returning on the same day should be tested.
- 8. Day trippers from Northeast State to be tested.
- 9. The Market Committees and the Dorbar Shnong are requested to issue Odd and Even Nos. to all shops within their jurisdiction to avoid overcrowding. These shops shall open on alternate days with immediate effect.

10. In addition, the public are requested to strictly:

- Maintain Social Distancing of at least 1 metre.
- Not to overcrowd in one area/ shop.
- To wear mask. This is mandatory.
- Not to spit in public places.
- Cooperate with management made by the District Administration, District Police and Headman.

In view of the urgency of the matter, this Order has been made ex parte.
