## Special Financial Assistance for Medical Oxygen Production in Madhya Pradesh

### 1. Background

India is going through a severe medical crisis due to Covid-19 pandemic, which is also affecting the country socially and economically. The second wave of pandemic has put severe pressure on already stressed health infrastructure across the country. Shortage of medical oxygen has become most eminent threat in treatment of patients and Madhya Pradesh is also facing this shortage of medical oxygen. The state, as of now, has no large plant for manufacturing of medical oxygen. A few plants are in pipeline and few industries are supporting in these critical times by converting industrial oxygen to medical grade oxygen, however, to ramp up the production capacities in short span, government support is imperative. Hence, this Special Financial Assistance is being introduced to incentivise industries to establish medical oxygen production plants and other oxygen related goods in the state of Madhya Pradesh.

### 2. Objective

- The objective of this special financial assistance is to promote local production of medical oxygen in Madhya Pradesh.
- To attract private investment in augmenting medical oxygen production capacity in Madhya Pradesh.
- To increase the production, storage and distribution capacity of medical oxygen in Madhya Pradesh.

### 3. Operative Period

The Scheme shall become effective from 1<sup>st</sup> May 2021 till 31<sup>st</sup> March 2022.

### 4. Definitions

- i. **“MSME Units”** – A manufacturing enterprise having an investment less than INR 10 crore in plant & machinery
- ii. **“Large Units”** – A manufacturing enterprise having an investment more than INR 10 crore in plant & machinery
- iii. **“Medical Oxygen”** – Oxygen suitable to be used for medical purposes
- iv. **“Medical Oxygen Cylinder Manufacturers/ fabricators”** – Production of medical oxygen cylinders meeting BIS standards (or higher) used for storage and distribution of medical oxygen
- v. **“Medical Oxygen Concentrator”** – Medical devices used to deliver higher concentration of oxygen to patients
- vi. **“Medical Oxygen production related equipment/ device”** – Any medical device used for creating/ providing medical oxygen to patients
- vii. **“DIPIP”** – shall mean Department of Industrial Policy and Investment Promotion, Govt of Madhya Pradesh
- viii. **“MPIDC”** – shall mean Madhya Pradesh Industrial Development Corporation
- ix. **“MSME Department”** – Shall mean Department of Micro, Small and Medium Enterprises, Govt of Madhya Pradesh





- x. **“Plant & Machinery”** – Investment made in plant and machinery shall include the investment made by the unit in plant, machinery, buildings, shed, NABL accredited quality certification and testing laboratories excluding investment made in land and dwelling units.

## 5. Eligibility:

- i. Micro, Small, Medium and Large greenfield industrial investments in MP or; existing oxygen producing units in MP undertaking capacity expansion or; existing units in MP willing to diversify in manufacturing / production of following:
  - a) Medical Oxygen
  - b) Medical Oxygen Cylinder including cryogenic containers
  - c) Medical Oxygen concentrators
  - d) Medical Oxygen production related equipment /devices

Expansion / Diversification unit shall be treated at par with new units for incentive purpose. In order to qualify under expansion/diversification, existing large units need to commit at least 30% (minimum INR 10 Crore) of the investment made in pre-existing Plant and Machinery or INR 50 Crore, whichever is less.

Prevalent definition of MSME department will be applicable for capacity expansion / diversification of MSME units.

- ii. Greenfield or pre-existing operational medical colleges, hospitals and nursing homes can avail the benefits under the provisions of this special financial assistance provided they establish oxygen production units or medical oxygen cylinder manufacturing unit
- iii. Medical Oxygen producing units with minimum oxygen production capacity of 10 cubic meter per hour would be eligible to avail the incentives under the provision of special financial assistance.

## 6. Incentive Package for Eligible Units

- i. **Investment Promotion Assistance (IPA):** Basic Investment assistance at a flat rate of 50% of the investment made in Plant & Machinery with an overall cap of INR 75 Crores
  - a. Units will get additional assistance through Export Multiple and Employment Multiple as stated in clause 16.1.3 & 16.1.4 of Industrial Promotion Policy 2014 (Amended 2020).
  - b. IPA can be availed in 5 equal yearly instalments for large units in compliance with Gross Supply Multiple as stated in clause 16.1.2 of Industrial Promotion Policy 2014 (Amended 2020). MSME units can avail the incentives in 3 equal yearly instalments subject to meeting conditions as mentioned in their prevalent policy and applicable rules.
- ii. **Reimbursement of Expenditure incurred in Safety Standards:** Units can claim reimbursement of 50% of the expenditure incurred (maximum of INR 1

crore) by the eligible unit on safety standards such as firefighting equipment, etc.

- iii. **Rebate in Power Tariff:** Rebate of INR 1 per unit on prevailing power tariff. The rebate will be in addition to any rebate provided by MPERC. MPIDC or MSME department will reimburse this rebate to the investor in power tariff. The rebate can be availed for 3 years from date of commercial production. The rebate will be offered only on production of items mentioned under clause 5.(i)
- iv. MPIDC / MSME department shall facilitate units in obtaining permissions related to MP Pollution Control Board, Petroleum and Explosives Safety Organisation (PESO), Health Department, Govt of Madhya Pradesh and other Departments of GoMP.

## 7. Conditions for Implementation of Special Financial Assistance

- i. MPIDC will be responsible for processing of incentive claims under the mentioned special financial assistance, for units with investment of more than INR 10 Crore in Plant & Machinery. The disposal will be as per the provisions and conditions mentioned in the Investment Promotion Policy 2014, amended from time to time
- ii. MSME Department will be responsible for processing and disposal of incentive claims under the mentioned special financial assistance, for units with investment less than INR 10 Crore in Plant & Machinery. The disposal will be as per the provisions and conditions mentioned in the prevailing MP MSME Development Policy 2017, amended from time to time
- iii. For investment more than INR 10 Cr, Investors shall have to file their investment proposal through the Single Window System developed by MPIDC and obtain a registration/ intention number to avail incentives under this Scheme.
- iv. For investment less than INR 10 Cr, prevalent mechanism of MSME Department shall be followed
- v. The eligible Medical Oxygen Producing units can also produce industrial oxygen and they will be eligible for incentives under this special financial assistance.
- vi. This special financial assistance shall be over and above any incentives being availed by the units from any Government of India Scheme. Units shall submit a declaration of types and quantum of incentives being availed / to be availed by them under such Government of India scheme. However total incentives from all the schemes put together shall not exceed 100% of the investment

made in Plant & Machinery (GoMP special financial assistance shall be reduced to that extent)
