O R D E R S

Imphal, the 16th April, 2021

WHEREAS, the undersigned Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005, issued order of even No. dated 31/03/2021 issued detailed guidelines relating to Test, Track and Treat and other additional conditions relating to gathering of people to be in force till 30/04/2021.

2. WHEREAS, the number of infections has increased exponentially in the last fortnight necessitating many states to impose partial lockdown and night curfews to reduce unnecessary movement and intermingling of people.

3. NOW THEREFORE, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 the undersigned in his capacity as Chairperson, State Executive Committee of the State Disaster Management Authority in continuation of the order referred to above, hereby orders for imposition of **NIGHT CURFEW** from 8 pm to 4 am every day.

4. The curfew imposed shall not be applicable to the categories listed below and shall be allowed free movement.

- i. All goods carrier vehicles including medical oxygen.
- ii. All essential service establishments like Pharmacies, Clinics, Hospitals, Power supply, Public Health Engineering, Municipal offices engaged in cleaning, Fire Services and medical oxygen manufacturing plants.
- iii. All personnel of the establishments mentioned at ii above including that of Veterinary services
- iv. All government officials who have been assigned specific duties of Covid-19 management or other emergency services.

5. All Deputy Commissioners / District Magistrates shall issue orders under CrPC for their district and enforce the above strictly.
